RecyclingWorks Spotlight: IEC Partners

The International Entrepreneurship Center (IEC Partners) is a private consulting organization that recently acquired an office facility in Newton. IEC Partners' Office Manager, Elisangela Libby, reached out to RecyclingWorks when she discovered 1,300 brand-new plastic bedpans in storage that needed to be removed. Elisangela was highly motivated to donate the bedpans, but found local health care facilities were unable to accept them.

RecyclingWorks connected IEC Partners to the Free Mason Hospital Loan Fund, a hospital equipment loan program in Woburn that works closely with NuDay Syria, a non-profit organization based out of New England that provides humanitarian aid and medical relief to help displaced Syrians. NuDay Syria was happy to accept the bedpans and will send them to Turkey, where they will help displaced Syrian families. Elisangela was thrilled when RecyclingWorks told her the bedpans (1.7 tons of rigid plastic) will be diverted from landfills and donated to a good cause: "I can't thank you enough for your efforts on helping me with this. I sincerely appreciate it. I could not have been happier with this outcome!"
