

Commercial Organics Hauling Customers in Massachusetts

Businesses and institutions across Massachusetts are joining the initiative to divert food waste from disposal. RecyclingWorks has been collecting data directly from organics haulers on the number of commercial organics customers in Massachusetts each year. From 2014 to 2018, the number of commercial organics customers in Massachusetts increased from approximately 1,350 to 2,300, representing a 70% increase or 950 additional businesses and institutions. RecyclingWorks Spotlight: Judd Wire

Judd Wire is a manufacturing facility in Turners Falls that produces high-technology electronic wire and cable products for the automotive and aerospace industries. The company generates a wide range of waste, including single stream recyclables, film plastics, thermoplastic polymers, copper, and various metal compounds. Judd Wire reached out to RecyclingWorks to request assistance with increasing their diversion of these materials.

After receiving technical assistance, Judd Wire made significant improvements to their recycling program by installing additional collection bins in their facility, refining signage, and launching a comprehensive educational program for all staff. Through these efforts, Judd Wire was able to increase their annual waste diversion to include an additional 3 tons of cardboard, 2 tons of film plastic, and 1 ton of single stream materials. Featured Article

<u>Waste 360</u> recently reported on the Massachusetts Department of Environmental Protection (MassDEP) enforcement of statewide <u>Waste Disposal Bans</u>. These bans are an important part of the department's comprehensive strategy to encourage recycling in the state. In 2018, the agency issued 119 notices of non-compliance to entities found violating the waste bans. More than 80 percent of observed waste ban violations are for cardboard, a material that is readily recyclable with well-established local markets for processing and manufacturing.

Entities that receive a notice of non-compliance are required to respond to MassDEP to describe their strategy to prevent disposal of banned materials. All businesses and institutions are encouraged to take advantage of the free educational resources and technical assistance offered through Recycling Works in Massachusetts, a MassDEP-funded program that helps these entities reduce waste and improve recycling practices.
