RecyclingWorks Website Update: De-packaging Facilities

Packaged foods may be thrown away when they are out-of-date, mislabeled, damaged, or spoiled. De-packaging facilities across Massachusetts are making it easier for businesses and institutions to divert packaged foods from disposal. RecyclingWorks in Massachusetts (RecyclingWorks) recently published an updated list of the organizations managing packaged food material from Massachusetts. These nine companies are either currently accepting packaged food material for de-packaging or are actively developing de-packaging facilities.

This resource is particularly relevant for food manufacturers, distributors, and retailers that need an outlet for out-of-date, mislabeled, damaged, or spoiled packaged food items.

RecyclingWorks Spotlight: The Lenox Hotel Case Study

The Lenox Hotel is a historic luxury hotel in Boston with a long history of commitment to sustainability. The hotel has maintained a successful food waste diversion program for four years, eventually expanding its diversion strategies across the EPA's Food Recovery Hierarchy. RecyclingWorks recently published anew video case study featuring the hotel's food waste diversion program to share their story with other businesses.

RecyclingWorks assisted the hotel in implementing a successful composting program in 2014. Since then, the hotel has identified opportunities to expand its food waste diversion and has begun donating excess food to local food rescue organizations to help people in need. Through its efforts, the hotel has started donating over 80 meals per month and diverting 312,000 pounds of food scraps for composting each year.

The <u>Paper Shipping Sack Manufacturers</u>

<u>Association</u>recently announced to businesses and institutions that clean, unlined paper shipping sacks may be recycled with corrugated cardboard boxes. In order to divert this valuable material from disposal, the association recommends that businesses empty all contents from the sacks and then collect with other corrugated materials to be recycled.
