RecyclingWorks FY19 Annual Report

During the last fiscal year, RecyclingWorks in Massachusetts (RecyclingWorks) assisted over 1,600 businesses, diverting over 3,400 tons of material from disposal. This contributes to an overall cumulative program impact of more than 140,000 tons of material diverted since 2013.

- quality, organics diversion, construction & demolition materials, and plastics recycling.
- Amongst other resources, RecyclingWorks
 developed new content to assist with
 commercial <u>single stream recycling</u>, incorporating
 the guidance MassDEP offers through the Recycle
 Smart MA initiative. The webpage also features a
 new educational graphic that instructs employees
 who collect and transport materials on <u>how to keep</u>
 single stream materials separate from the trash.
- After engaging various stakeholders across the state, RecyclingWorks published best management practices for <u>Business & Institutional Furniture and</u> <u>Office Equipment Reuse</u>. The new guidance webpage discusses different types of reuse outlets, offers tips for developing a furniture reuse plan, describes the requirements for state facilities, and includes a list of reuse organizations that service businesses and institutions in Massachusetts.
- RecyclingWorks continued to reach new businesses through targeted outreach and inperson presentations and conferences. Throughout FY19, RecyclingWorks reached over 1,000 attendees at 28 events to increase awareness of program services and resources and to provide technical guidance on topics related to reuse, recycling, and food waste diversion.

The Massachusetts Department of Environmental Protection (MassDEP) has posted the <u>Draft Massachusetts 2030 Solid Waste Master Plan</u> and public hearing notice. This plan provides the framework, direction, and goals for solid waste reduction and management policy for the state. The website and notice list the dates, times, and locations of public hearings. The public comment period will run until December 6, 2019 and comments can be submitted to <u>dep.swmp@mass.gov</u> or to John Fischer, MassDEP, One Winter Street, Boston, MA 02108.

RecyclingWorks College & University Waste Ban Compliance Tips

RecyclingWorks developed a new <u>Waste Ban Compliance</u>
<u>Tip Sheet</u> for Massachusetts colleges and universities. This document includes information about waste ban materials that higher education institutions are likely to have on campus, such as cardboard & paper, containers, construction & demolition materials, and food waste.

Colleges and universities that generate one ton or more of food waste per week are subject to the <u>commercial organics</u> waste ban.
